

**FACTS****WHAT DOES MATTAMY INSURANCE AGENCY, LLC DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and insurance claim history</li> <li>▪ Account balances and payment history</li> <li>▪ Credit history and credit-based insurance scores</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Mattamy Insurance Agency, LLC chooses to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	Mattamy Insurance Agency, LLC
What we do	
<b>How does Mattamy Insurance Agency, LLC protect my personal information?</b>	To protect your personal information from unauthorized access and use, we maintain physical, electronic, and procedural safeguards that comply with state and federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Mattamy Insurance Agency, LLC collect my personal information?</b>	We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>▪ apply for insurance or pay insurance premiums</li> <li>▪ provide account information or give us your contact information</li> <li>▪ file an insurance claim</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit: <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

### Definitions

<b>Affiliates</b>	Companies related to Mattamy Insurance Agency, LLC by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Our affiliates include financial companies such as Mattamy Homes Title Agency, LLC, Mattamy Home Funding, LLC and Hippo Insurance Services.</li> </ul>
<b>Nonaffiliates</b>	Companies not related to Mattamy Insurance Agency, LLC by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Mattamy Insurance Agency, LLC does not share with nonaffiliates so they can market to you.</li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ Our joint marketing partners include mortgage companies, insurance companies, insurance agencies, and companies that provide financial products and services.</li> </ul>

### Other Important Information

We will also comply with any applicable state laws to the extent they apply.

**California Residents:** We will not share your information with nonaffiliated third parties for their marketing purposes except with your express consent. California residents will also be provided an "Important Privacy Choices" notice explaining their rights under the California Financial Information Privacy Act.

**Nevada Residents:** This notice is provided to you pursuant to state law. You may be placed on our internal Do Not Call List by calling (800) 304-6173. **You have the right to control whether we share some of your personal information.**

### **Your Rights**

You have the following rights to restrict the sharing of personal and financial information with our affiliates (companies we own or control) and outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your account with us. This includes sending you information about some other products or services.

### **Your Choices**

**Restrict Information Sharing With Companies We Own or Control (Affiliates):** Unless you say “No,” we may share personal and financial information about you with our affiliated companies.

**Restrict Information Sharing With Other Companies We Do Business With To Provide Financial Products And Services:** Unless you say “No,” we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.
